ITEM DESCRIPTION

Recommendation to Extend Purchasing Agreement PS-608A Airport Consulting Services with LeighFisher, Inc.

BACKGROUND

On December 13, 2023, the Aviation Authority Board approved the recommendation to extend the Purchasing Agreement PS-608 Airport Consulting Services with LeighFisher, Inc. (LeighFisher) and Ricondo & Associates, Inc. (Ricondo) to December 31, 2024. The scope of services include, but are not limited to, the following:

- Prepare a Report of the Airport Consultant to be included in the Aviation Authority's Official Statements in connection with the issuance of bonds;
- Provide a report of estimates and financial projections pursuant to the Aviation Authority's Airport Facilities Revenue Bond Resolution, prior to the issuance of additional bonds;
- In conjunction with issuance of revenue bonds and the publication of Official Statements relating to those bonds, provide aviation market and traffic studies;
- Assist in negotiations with airlines, projecting rates by resolution, or providing information on current airport industry practices;
- Advise the Aviation Authority on how to view or evaluate the Airport's competitive position with other airports, both in this region and elsewhere, and how to consider or influence the relative competitive positions of tenants at the Airport's terminal;
- Aid the Aviation Authority in interpreting the Federal Aviation Administration's (FAA) policy on Rates and Charges in analyzing or defining the Airport's Rates and Charges policy;
- Provide support for the Aviation Authority's rates and charges forecasting model;
- Develop rate structures for airport service facilities that include capital recovery;
- Analyze and advise on financial impacts of proposed capital projects; develop capital project financing strategies, including cash flow analysis and preparation of rates and charges scenarios as needed to help make capital financing decisions; participate in planning and development of capital projects with other Aviation Authority consultants, including but not limited to Proposers providing master plan, engineering, architectural, and environmental services;

• Provide feasibility studies and or business marketing planning and analysis of existing and potential retail and or concession programs for the Aviation Authority and participate in the development and establishment of Airport retail and or concessions programs; and

• Assist with FAA and Passenger Facility Charges applications and eligibility issues.

ISSUES

During 2024, the Aviation Authority was actively engaged on two essential initiatives that require Airport Consulting Services:

- 1) Airline negotiations to amend the Resolution relating to Airline Rates and Charges and Airline Operating Terms and Conditions for the Use of Facilities and Services at Orlando International Airport, which expired on September 30, 2024.
- 2) Series 2024 Airport Facilities Revenue Bonds in support of the Aviation Authority's Capital Improvement Plan, which is expected to close December 19, 2024.

Staff has completed work on the Airline Rates and Charges and Rate Methodology. LeighFisher assisted in negotiations with airlines, projecting rates by resolution, providing information on current airport industry practices, as well as provide key support for the Aviation Authority's rates and charges forecasting model and 2024 Bond transaction.

Preliminary estimates, financial projections, and aviation market and traffic studies in support of the Fiscal Year 2026 budget will begin in the spring of 2025 and will be adopted at the September 2025 Board meeting.

In an effort to safeguard business continuity and maintain the seamless operation of this critical budget process, and in light of recent baggage initiatives and the pursuit of TIFIA funding to facilitate the proposed ConRAC program, we respectfully recommend to extend the Airport Consulting Agreement with LeighFisher for six months, beginning January 1, 2025, and expiring on June 30, 2025. A new procurement for Airport Consulting Services will be issued by the end of the calendar year.

SMALL BUSINESS

Not applicable.

ALTERNATIVES

There are no reasonable alternatives under consideration.

FISCAL IMPACT

Fees for services, other than financing transactions, shall be invoiced in detail based on the hourly rates agreed upon in Exhibit B of the Professional Services Agreement for Airport Consulting Services with LeighFisher. The fiscal impact anticipated for the six-month extension of Airport Consulting Services, other than financing transactions, shall be allocated from the Operations and Maintenance Fund in an amount not-to-exceed \$175,000. Required funding will be approved through the budget process and when funds become available.

A negotiated fee cap will be set for all Aviation Authority bond transactions or other significant financing transactions and projects, which will be paid from the proceeds of the transaction, and will be presented to the Board for approval separately with each transaction. At this time no bond transactions are anticipated during the proposed extension period.

RECOMMENDED ACTION

It is respectfully requested that the Procurement Committee resolve to: (1) extend the term of Purchasing Agreement PS-608A Airport Consulting Services with LeighFisher, Inc., for six months beginning January 1, 2025, and expiring on June 30, 2025; (2) approve fees for consulting services, exclusive of fees for bond transactions or other significant financing transactions, to be allocated from the Operations and Maintenance Fund for an aggregate not-to-exceed amount of \$175,000; and (3) authorize staff to take any and all actions and execute any and all documents deemed necessary to extend PS-608A Airport Consulting Services with LeighFisher, Inc., subject to satisfactory legal review.

ITEM DESCRIPTION

Request for Approval of Amendment to Addendum 13 to the Continuing Transportation Planning Services Agreement with HDR Engineering, Inc. for a No-Cost Rates Increase for Fiscal Year 2025 On-Call Transportation Planning Services at the Orlando International Airport (MCO).

BACKGROUND

In 2021, the firms providing Continuing Transportation Planning Services were selected through a competitive award process. These services are procured on an as-needed or annual basis.

On May 19, 2021, the Aviation Authority Board approved a Continuing Transportation Planning Services Agreement with the following firms:

- HDR Engineering, Inc.
- HNTB Corporation

These no-cost base agreements established the negotiated hourly rates. These services consist of the performance of transportation planning services and related professional services, and may include, but not be limited to, onairport roadway traffic counts, multi-modal transportation facility planning, airport passenger surface access-related analyses, coordination with local, regional, state and federal transportation agencies on transportation planning issues to support the development of the Aviation Authority's existing and future facilities; assisting with strategic development planning, planning analyses of roadway opportunities and constraints, wayfinding and signage, and other miscellaneous transportation projects and all other related services including coordination with the Aviation Authority, its Consultants, the City of Orlando and all agencies having jurisdiction over the facilities. The Services may also include, but are not limited to, studies and preparation of reports involving scope definition and validation of projects, evaluation and documentation of existing conditions; Master Document support, plan review and support of the Aviation Authority's horizontal permitting program, technical support and review of documents prepared by others, management support on various Aviation Authority projects and all other related professional support and review.

ISSUES

On September 3, 2024, the Aviation Authority Board approved Addendum 13, Fiscal Year 2025 On-Call Transportation Planning Services. These services include, but are not limited to, performing miscellaneous transportation planning and traffic engineering tasks requested by the Aviation Authority that are not associated with other on-going work authorizations. Since this approval, HDR Engineering, Inc. negotiated new rates with the Aviation Authority. This amendment is to update the rates that we approved under Addendum 13.

Services cannot commence before the date of Procurement Committee approval. The approved amendment must be executed by the Aviation Authority before invoicing for services of the new rates.

The cumulative contract value of all addenda/amendments since the last approval by the Aviation Authority Board for the Continuing Transportation Planning Services Agreement with HDR Engineering, Inc. does not exceed the \$250,000 threshold; thus, this agenda item does not require Board approval.

SMALL BUSINESS

The Small Business Department reviewed the scope of the above referenced solicitation and did not recommend a small business participation goal.

ITEM DESCRIPTION

Request for Approval of Amendment to Addendum 14 to the Continuing Transportation Planning Services Agreement with HDR Engineering, Inc. for a No-Cost Rates Increase for Fiscal Year 2025 Horizontal Development Review Services at the Orlando International Airport (MCO).

BACKGROUND

In 2021, the firms providing Continuing Transportation Planning Services were selected through a competitive award process. These services are procured on an as-needed or annual basis.

On May 19, 2021, the Aviation Authority Board approved a Continuing Transportation Planning Services Agreement with the following firms:

- HDR Engineering, Inc.
- HNTB Corporation

These no-cost base agreements established the negotiated hourly rates. These services consist of the performance of transportation planning services and related professional services, and may include, but not be limited to, onairport roadway traffic counts, multi-modal transportation facility planning, airport passenger surface access-related analyses, coordination with local, regional, state and federal transportation agencies on transportation planning issues to support the development of the Aviation Authority's existing and future facilities; assisting with strategic development planning, planning analyses of roadway opportunities and constraints, wayfinding and signage, and other miscellaneous transportation projects and all other related services including coordination with the Aviation Authority, its Consultants, the City of Orlando and all agencies having jurisdiction over the facilities. The Services may also include, but are not limited to, studies and preparation of reports involving scope definition and validation of projects, evaluation and documentation of existing conditions; Master Document support, plan review and support of the Aviation Authority's horizontal permitting program, technical support and review of documents prepared by others, management support on various Aviation Authority projects and all other related professional services.

ISSUES

On September 3, 2024, the Aviation Authority Board approved Addendum 14, Fiscal Year 2025 On-Call Horizontal Development Review Services. These services include, but are not limited to, the review of proposed horizontal development within properties controlled by the Aviation Authority. Since this approval, HDR Engineering, Inc. negotiated new rates with the Aviation Authority. This amendment is to update the rates that we approved under Addendum 14.

Services cannot commence before the date of Procurement Committee approval. The approved amendment must be executed by the Aviation Authority before invoicing for services of the new rates.

The cumulative contract value of all addenda/amendments since the last approval by the Aviation Authority Board for the Continuing Transportation Planning Services Agreement with HDR Engineering, Inc. does not exceed the \$250,000 threshold; thus, this agenda item does not require Board approval.

ITEM DESCRIPTION

Request for Approval of an Amendment to Addendum 68 to the General Consulting Services Agreement with Ricondo & Associates, Inc. for Pre-Planning Activities for Environmental Assessment Development at the Orlando International Airport.

BACKGROUND

December 2020, Ricondo & Associates, Inc. was selected by the Aviation Authority Board through a competitive award process to provide General Consulting Services. Tasks are awarded on an as-need or annual basis.

On June 19, 2024, the Aviation Authority approved Addendum 68 with Ricondo & Associates for Pre-Planning Activities for Environmental Assessment Development at the Orlando International Airport. On August 21, 2024, the Aviation Authority Board Approved Amendment No. 1 to Addendum 68 with Ricondo & Associates for Pre-Planning Activities for Environmental Assessment Development at the Orlando International Airport.

ISSUES

The Consultant's proposal, dated October 28, 2024 is for a retroactive request. Since the time of the approvals, Ricondo has made staffing changes and is requesting additional positions. The scope remains the same as originally described in the approved agreements. This is a no cost item.

If approved, services will be effective the date of the Procurement Committee approval retroactive to June 19, 2024.

The cumulative contract value of all addenda/amendments since the last approval by the Aviation Authority Board for the General Consulting Services Agreement with Ricondo & Associates, Inc. does not exceed the \$250,000 threshold; thus, this agenda item does not require Board approval.

The Small Business Department reviewed the scope of the above referenced solicitation and did not recommend a

small business participation goal.

Dear Mr. Marble:

Ricondo & Associates, Inc. (Ricondo) received the executed Addendum No. 68 to the General Consulting Services Agreement from Greater Orlando Aviation Authority (the Aviation Authority) on June 19, 2024. This executed addendum authorized Ricondo and its subconsultants to support the Aviation Authority for Pre-Planning Activities for Environmental Assessment Development at Orlando International Airport.

The Ricondo scope of work and fee proposal included a Table with approved positions and rates for Ricondo for a Senior Officer, Officer, Manager, and Technical Editor.

As noted in our proposal for Addendum 68, Pre-planning Activities for Environmental Assessment, which is related specifically to the proposed Consolidated Rental Car Facility (ConRAC), Ricondo's role includes supporting the development of the project definition and background, and work with ESA to complete the alternatives analysis, provide project oversight, and complete a technical editorial review of the final deliverables. To accomplish this, Ricondo anticipated labor effort would be provided from the Senior Officer (e.g. Pete Ricondo), Officer (e.g. Lisa Reznar), Manager (e.g. Foo Pham), and a technical editor.

At the request of ESA, a couple of coordination calls were held with representatives from ESA and Mr. Chris Wilson to explain the roadway improvements included as part of the ConRAC and Terminal C PDD projects. Ricondo was asked during these calls to provide drawings to ESA for their use in the preplanning activities. Participation on the aforementioned calls included Pete Ricondo and our Task Leader for the roadway improvements (Mr. Jason Garman). The subsequent development of drawings required budget availability for Senior Director, Director, and Consultant positions. This is not intended to be a change in staffing (the original positions are still engaged in the project), but rather, a request to include these additional positions for production work that should be performed by lower-cost labor positions. The effective date of this change is July 2, 2024. GOAA has been aware since the initiation of this project that we are supporting ESA with the information they need to complete their work.

The positions required include:

- Senior Director \$295/hour
- Director \$239/hour
- Senior Consultant \$139/hour
- Consultant \$93/hour

We have provided an updated Table C-5 that includes updated estimated hours that are within the originally proposed budgets. There are no changes to the subconsultant positions on this project, the project fee, or the scope of work being performed.

Financial Impact

All of the above requested positions and rates have been previously approved by GOAA. This request is a no-cost request for additional approved positions and the project budgets will not be affected.

ITEM DESCRIPTION

Request for Recommendation to the Aviation Authority Board to Award Invitation for Bid 25-110-IFB Automatic Door Repair, Maintenance and Upgrade Services to Allegion Access Technologies, LLC.

BACKGROUND

On August 23, 2024, the Aviation Authority issued an Invitation for Bid 25-110-IFB for Automatic Door Repair, Maintenance and Upgrade Servies. The term of the Contract will be for five years with the initial service starting on January 01, 2025.

The Contractors shall provide automatic door repair, maintenance and upgrade services for approximately 250 Stanley, Horton and Besam automatic sliding and swing doors located at the Orlando International Airport and Orlando Executive Airport.

The Services will be provided on an "as-needed" basis, in accordance with the American Association of Automatic Door Manufacturer standards. Repairs will be provided by trained and certified personnel using original equipment manufacturer parts.

ISSUES

On October 1, 2024, the Aviation Authority received the following responses:

Staff reviewed the submittals and references for all bidders, and based thereon, all were determined to be responsible and responsive to the Invitation for Bid requirements. Staff recommends award to Allegion Access Technologies LLC as the lowest and responsible bidder for an amount not to exceed \$533,750.00 for the five-year period.

The amount paid to the Contractors will be based on actual work requested, performed and approved by the Aviation Authority based on hourly rates and cost of parts.

SMALL BUSINESS

The Small Business Department reviewed the scope of the above referenced solicitation and did not recommend a small business participation goal due to the limited scope and the lack of certified small business firms that are ready, willing, and able to participate.

ALTERNATIVES

There are no reasonable alternatives under consideration.

FISCAL IMPACT

The value of this procurement is a not-to-exceed amount of \$533,750.00 for the five-year Contract period. Funds anticipated to be spent under the Contract in the current fiscal year are within budget. Funding required in the current and subsequent fiscal years will be allocated from the Operations and Maintenance Fund, as approved through the budget process and when funds become available.

RECOMMENDED ACTION

It is respectfully requested that the Procurement Committee approve that the following be recommended to the Aviation Authority Board to: (1) award Invitation for Bid 25-110-IFB to Allegion Access Technologies LLC. as the low responsible and responsive bidder for a total amount not to exceed \$533,750.00; (2) authorize funding from the Operations and Maintenance Fund; and, (3) authorize the Chief Executive Officer or an Aviation Authority Officer to execute the necessary documents following satisfactory review by Legal Counsel.

ITEM DESCRIPTION

Request for recommendation to the Aviation Authority Board for Approval of Amendment No. 3, Contract Adjustment, for Procurement Contract 24-101-A-RFP Information Technology Continuing Consulting Services Agreement to Barich Inc.

BACKGROUND

On April 24, 2024, the Aviation Authority Board awarded Request for Proposal, 24-101-RFP, Information Technology Consulting Services to Barich Inc. The Contract will expire on May 31, 2029.

The Contract requires Barich Inc. to provide a broad range of services associated with the planning and implementation of IT projects and initiatives that are identified in the Aviation Authority's Capital Improvement Plan (CIP), Information Technology Master Plan (ITMP), the Aviation Authority's annual project planning process, and other IT projects and initiatives requested by the Aviation Authority. The Services may include project management; staff augmentation; research of specific technologies; research and concept development; IT business analysis; business case development, infrastructure and applications design, installation, configuration, development and testing; database management and administration; cyber and physical security; development of solicitation documents; functional, performance and interface requirements definition and documentation project planning; applications development, implementation and integration across multiple systems; operations and management of IT; assistance with IT roadmap or strategic plans; vendor and product evaluations and recommendations and other IT consulting services.

ISSUES

Contract Adjustment – The Staff is requesting that the agreement be adjusted to include the following task in the scope of work: The consultant will assess Terminal C infrastructure at the Orlando International Airport.

During the construction of South Terminal C, the increase in tenants and vendors required fiber optic connections above what was a part of the overall design. Contractors made the connections as needed, however the documentation for some of these connections was not necessarily provided as part of the as-built documentation. The IT department requires this updated documentation to provide connectivity to new and existing tenants, vendors, and Authority groups as requests are brought forth. This documentation will also provide Authority IT with the necessary information for expanding the fiber infrastructure as needed where current fiber is approaching complete usage. The data that is provided by Burns will be integrated into our Cable Management GIS Software. This information is also critical for fiber infrastructure design required by our clients, and the estimates that IT is required to provide for these designs. Without a complete understanding of available and used fiber throughout Terminal C (both landside and airside) delays in creating the necessary connections will occur when fiber is not readily available for use. This contract adjustment is for the completion of the inventory of the Landside and Airside Terminals to identify all fiber paths that are currently in use and available for the purpose of aiding in labeling any missing inventory.

These services will assess the existing backbone fiber pathways, including site duct bank and intra-building conduits for South Terminal C while documenting existing cables and identifying available dark fiber strands. Barich Inc. will be subcontracting Burns Engineering for this task. Burns will perform the inventories and perform the verifications and comparisons to as-built documents and reconcile data within the Aviation Authority's AutoCAD and GIS files. Burns will also review the labeling of the various fiber channels, and ensure it meets IT standards.

The Aviation Authority Information Technology staff presently maintains a record of information for the remainder of the campus that includes duct bank routing and pathway, specific cables installed, dark fiber capacity, and MDF/IDF terminations. The records are comprised of project as-built drawings, AutoCAD files and GIS.

The total cost for Amendment No. 3 is a not-to-exceed amount of \$243,440. Pricing is based on an hourly rate. The actual amount paid is based on actual work requested by the Aviation Authority and satisfactorily provided by the consultant.

SMALL BUSINESS

The Aviation Authority's Professional Service participation program goal is 17% for Goods and Services. For this solicitation, small business participation will be assessed on a case-by-case basis, based on each project's actual scope of work and availability.

The Small Business Development Department has reviewed Barich, Inc.'s proposal for Amendment No. 3 and determined that, due to the limited and specialized scope of services to be provided, Barich, Inc. does not propose any small business participation for this amendment.

FISCAL IMPACT

The fiscal impact of this award is a not-to-exceed amount of \$243,440 with funding from previously approved Capital Expenditure funds from project W-S00155.

RECOMMENDED ACTION

It is respectfully requested that the Procurement Committee approve the following be recommended to the Aviation Authority Board: (1) approve Amendment No. 3, Contract Adjustment to Procurement Contract 24-101-A-RFP,Information Technology Continuing Consulting Services with Barich Inc.; (2) authorize funding from Capital Expenditure Funds in a not-to-exceed amount of \$243,440; and (3) authorize the Chief Executive Officer or an Aviation Authority Officer to execute the necessary documents following satisfactory review by legal counsel.
